Stock Memberships: New Stock may be purchased on an installment plan with at least \$250.00 down and the balance paid by September 1 of the current year. For existing Stock or Heritage members, membership dues shall be paid by July 1 or the Treasurer will deduct the outstanding amount from the Stock Certificate value. Each stock member in good standing of the Association shall be entitled to be present and shall have one vote at all stock membership meetings. Regardless of the number of stock certificates owned by a member, he shall have only one vote. Only Stock members are entitled to vote on membership issues.

***Summer Memberships:** Memberships may be purchased on an installment plan with a least one third down and the balance paid by July 1 of the current year. Balances outstanding after July 1 will have a \$20 late fee applied and a suspension of pool privileges until balance is reconciled. Membership must be reapplied for each year.

All Memberships: Membership entitles the member, spouse and all members of the family less than 25 years of age, permanently residing therewith, to use the Association facilities subject to its rules and regulations.

Returned Checks: All returned checks will result in a \$25 penalty and payment in cash will be required.

Northampton Pool Association is a private organization. It reserves the right to refuse an application for membership when it is deemed it is in the best interests of the Association.
